

AGREEMENT № 04-28/56
on cooperation
between the Dr. Jaffaly Haled Dentist Clinic and
Dnipro University of Technology

Dnipro University of Technology (DUT) (hereinafter referred to as the "University") in the person of Artem PAVLYCHENKO, the first vice-rector, acting on the basis of the Charter, on the one hand, and the "Dr. Jaffaly Haled Dentist Clinic" (hereinafter referred to as the "Enterprise") in the person of the owner Jaffaly Haled, acting on the basis of the Charter, on the other hand, (together - the "Parties") have entered into this agreement (hereinafter referred to as the "Agreement") on the following:

1. SUBJECT OF THE AGREEMENT

The subject of this Agreement is cooperation in the fields of biotechnical and medical materials science and biomedical engineering in the direction of educational, methodological, research work, information and advisory services, mutual exchange of experience and professional development in order to improve the quality of training of specialists, consolidation of theoretical knowledge and their practical application in production.

2. OBLIGATIONS OF THE PARTIES

2.1 The University is obligated to:

- ensure meetings of authorized persons to determine priority areas of cooperation of mutual interest;
- cooperate on the basis of mutual benefit and trust, maintain business contacts and take all necessary measures to ensure efficiency and promote the development of partnership relations;
- exchange information on the basis of mutually beneficial relations, which is not confidential (the information that is transferred must be open and non-confidential);
- organize and conduct joint events, including scientific and practical seminars, conferences, round tables;
- conduct joint research works, publish the results;
- refrain from actions that may negatively affect the activity or business reputation of the other party to the Agreement;
- conduct joint consultations, provide the opportunity for employees of both Parties to participate in them. Lecturers of the department of mechanical and biomedical engineering can provide scientific consulting to the Enterprise free of charge, namely:
 - Head of Dept., Prof., Doct. of Eng. Sc. Kolosov D.L. – on the use of composite materials and finite-element modelling in biotechnical and medical materials science and biomedical engineering;
 - Prof., Ph.D., Assoc. Prof. Dolgov O.M. – on the use of composite materials in biotechnical and medical materials science and biomedical engineering;
 - Assoc. Prof., Ph.D. Onyshchenko S.V. – on the use of composite materials and finite-element modelling in biotechnical and medical materials science and biomedical engineering;
 - Assoc. Prof., Ph.D., Assoc. Prof. Panchenko S.P. – on biomechanics and finite-element modelling in biotechnical and medical materials science and biomedical engineering;
 - Assoc. Prof., Ph.D. Slupska Yu.S. – on the use of innovative materials in biotechnical and medical materials science and biomedical engineering;
 - Assoc. Prof., M.D., Ph.D. Mametiev A.O. – on the use of innovative methods of rehabilitation in biotechnical and medical materials science and biomedical engineering;
 - Senior Lecturer Naumenko O.H. – on the use of innovative materials in biotechnical and medical materials science and biomedical engineering;

- Senior Lecturer Kiba V. Ya. – on the use of innovative materials in biotechnical and medical materials science and biomedical engineering;
- Assistant Professor Chechel T.O. – on the use of innovative materials and finite-element modelling in biotechnical and medical materials science and biomedical engineering.

2.2 The enterprise is obligated to:

- ensure meetings of authorized persons to determine priority areas of cooperation of mutual interest;
- cooperate on the basis of mutual benefit and trust, maintain business contacts and take all necessary measures to ensure efficiency and promote the development of partnership relations;
- exchange information on the basis of mutually beneficial relations, which is not confidential (the information to be transferred must be open and non-confidential);
- conduct joint consultations, provide the opportunity for employees on both sides to participate in them;
- conduct joint research works, publish the results;
- organize and conduct joint events, including scientific and practical seminars, conferences, round tables;
- refrain from actions that may negatively affect the activity or business reputation of the other party to the Agreement;
- conduct advanced training of scientific and pedagogical workers.

3. ADDITIONAL CONDITIONS

3.1 This Agreement is concluded in two copies, which have the same legal force and are kept one by each of the Parties.

3.2 Amendments and additions to this Agreement shall be made in writing and signed by the Parties. The proposed changes and additions are considered within 10 working days from the moment they are submitted for consideration by the other party.

3.3 Under this Agreement, the Parties do not bear any financial obligations.

3.4 Individual specific areas of cooperation will be regulated by Additional Agreements signed by representatives of the Parties and affixed with seals.

4. TERM OF THE CONTRACT

4.1 This Agreement enters into force from the moment of its signing by the Parties and is valid for five years. The validity of this Agreement is automatically extended for the next five years, if none of the Parties notifies the other Party in writing of its desire to terminate this Agreement no later than three months before the end of the current period.

4.2 This contract may be terminated before its expiration in the following cases:

- in case of non-performance or improper performance by the Parties of their duties;
- in case of non-agreement of one of the Parties to make changes or additions to this Agreement;
- in case the Parties no longer need to cooperate;
- in case of adoption of regulatory legal acts that contradict or make impossible the implementation of this Agreement by the Parties;
- in other cases provided for by the current legislation of Ukraine.

In case of early termination of this Agreement, the Party initiating the termination shall notify the other Party ten days before the date of termination of the Agreement.
